1. Law No. 310/2021 on the prevention and fight against doping in sport

Anti-doping testing and investigations

Art. 44

(2)Anti-doping testing is carried out according to the National Annual Testing Plan, in compliance with the provisions of the International Standard for Testing and Investigations.

2. Government Resolution No. 278/2022 on the approval of the Methodological Norms regarding doping control

Art. 15

- (3)Prior to notifying the athlete, the sample collection authority, the Doping Control Officer or the chaperone, as the case may be, must establish whether a third party needs to be present for the notification, in the following situations:
- a) the athlete is a minor;

3. International Standard for Testing and Investigations – Annex B

- **B.3** Responsibility
- **B.3.1** The Testing Authority has responsibility for ensuring, when possible, that the DCO has any information necessary to conduct a Sample Collection Session with an Athlete who is a Minor. This includes confirming wherever necessary that the necessary parental consent is given for Testing any participating Athlete who is a Minor.
- **B.3.2** Where Sample collection involves an Athlete who is a Minor, the Testing Authority and/or Collection Authority shall designate at least two members of the Collection Staff to the Collection Session. The Collection Staff shall be informed in advance that the Sample collection involves (or may involve) Athletes who are Minors.

(Comment to B.3.2: for clarity, the two members of the collection staff may be two DCOs or one DCO and one BCO (Blood Collection Officer) or one DCO and one chaperone. The two persons shall always be present at the Doping Control Station for collection sessions involving An Athlete who is a Minor.)
